

Smoke Outlook for 9/02 - 9/03 NW California - Red Salmon Complex

Fire

The Red Salmon fire continues to be active on the southwestern edge and eastern side of the perimeter. Hot and dry weather will continue to promote fire growth and smoke production again today. Detailed fire information at: inciweb.nwcg.gov/incident/6891

Smoke

This morning, a large swatch of smoke sits elevated above the ground over the fire area, to the west over the coast, and far to the south. As the day warms, we can expect smoke to mix down and begin to impact communities in these areas; such as Forks of Salmon, Orleans, Hoopa Valley and Willow Creek. For the afternoon, a southwesterly transport wind is forecast, which will begin to drift smoke northerly, creating Moderate smoke impacts for Etna and the Scott Valley and possibly the Shasta Valley late in the day. Additionally, smoke from fires to the south will begin to move overhead into the forecast area this evening and potentially begin to add to degrading air quality starting tomorrow.
